I am under going treatment of since 30th September 2006 at Rainbow Children's Hospital, Karvy Lane, Banjara Hills, Hyderabad -- 500 034, INDIA. During therapy hospital stay I had fungal osteomyelitis of maxilla by which I lost my 10 teeths of upper jaw left. The doctor concerned reported that I need long term remission induction therapy. Presently Medical expenditure to treat me is approximately Rs.7,45,000/- (Rupees Seven laksh and forty five thousand only) are required.

I am from a poor family and my family members find it very difficult to support financially. My father is a daily wage labour.

My family members are not able to support me for medical expenses. In this scenario I humbly request you to support me and fill with new life. I fervently need assistance from you.


This 13 year old girl had admitted at us on 30th September 2006. She was diagnosed to have Malignant Immune Hemolytic Anemia, which is a rare blood disorder happens in one in 25 lakh population. Initially we tried her on IV immunoglobulins and Methylprednisolone for five days. She didn't responded very well. We discussed with the family of few options left out like IV Ritcauxmob, which is a very expensive/imported medicine, which acts against B-Lymphocytes.

She is a grown up girl of 13 years old, family had a poor back ground and very emotional and attached, kindly consider the family under compassionate grounds and do the needful.

The family is running out of financial resources and the approximate estimated bill is attached with this letter. I would be very grateful to you if you could help this family from your fund on compassionate grounds. The estimated approximate cost would be around Rs. 7,45,000/- (Seven Lakhs Forty Five Thousand Rupees only) for approximate period of another 5 - 6 weeks to complete the treatment and if she gets treatment without any interruption.


